



Illinois Community Canopy Tree Planting Grants

Program Rules, Eligibility, Details

1. Trees must be planted on public property.
2. Grant funding can only be used for the purchase of trees and CANNOT be used for other costs associated with the planting like stakes, tree tubes, mulch, delivery fees, etc.
3. Trees planted shall be between 1" and 1.5" caliper measured at 6" above the root flare.
4. Trees planted MUST be between 5-gallon and 10-gallon container sized trees (1" to 1.5" caliper trees). No balled and burlaped (B&B) trees are allowed. For questions about tree size and species selection contact an Illinois Field Coordinator.
5. Tree species selected must include a variety appropriate to your community. A statement explaining how the selected species will improve the tree canopy in your community is required as part of the tree planting plan.
6. Shrubs (species that do not grow beyond 10 feet in height) are not eligible for reimbursement.
7. Tree species to be planted should be specified in the grant application. Species selected and site conditions must be identified. Grant participants are encouraged to plant native species. The tree list planting and plan may be subject to change based on new information you receive during the grant period. However, any changes from the original proposal must be approved by Trees Forever prior to implementation.
8. Tree species that have invasive qualities shall not be planted under this program. Prohibited species includes the following, and any other invasive species, for a list of recommended species see here:

 - Callery pear (Bradford pear) or other exotic pear species- *Pyrus* spp.
 - Tree-of-heaven - *Ailanthus altissima*
 - Autumn olive - *Elaeagnus umbellata*
 - Mimosa - *Albizia julibrissin*
 - Norway maple - *Acer platanoides*
9. The Applicant must attest to properly caring for trees purchased through this program by including a maintenance plan. The plan must identify who will water and frequency for watering and mulching trees over the required three years post-planting period. If selected for funding, a copy of the proposed maintenance plan must be submitted with the application. A Tree Maintenance Agreement and Partner Commitment Agreement is required and is attached to the Application packet.)

10. Trees must be planted according to the ANSI, ISA, and/or other nationally recognized planting specifications.
11. All trees purchased through this proposal are preferred to be from nurseries that are licensed by the Illinois Nursery Inspection Program. Trees must be purchased from entities which are compliant with all applicable State and Federal regulations including spongy (gypsy) moth compliance agreements, pesticide licensure, etc. meaning trees should be purchased from grower nurseries and not tree brokers.
12. All trees must have any packaging such as burlap, rope, and wire baskets removed (or be a low-profile basket) at time of planting and must be planted in accordance with the ANSI A300 Standard. (also see Appendix C for a planting standard example).
13. Immediately after planting, all trees shall receive a 2 to 3-inch layer of hardwood mulch over the root ball. Mulch shall not touch the bark of the tree.
14. Tree planting shall take place in the spring or fall.
15. Newly planted trees must be digitally inventoried, or recorded, at planting. Communities may use a Microsoft Excel spreadsheet, or their own inventory software of choice. Information that must be collected includes: a photo of each planted tree, GPS coordinates, tree species, tree size (DBH), and tree condition. Trees Forever may periodically conduct site visits to ensure the accuracy of this digital inventory.
16. Grant awards are for a minimum of \$3,000. To be eligible for an additional tree planting grant, communities must achieve a capacity building milestone like development of a tree board, or adoption of tree ordinances, after which they are eligible for an additional tree planting grant.
17. No match is required but only eligible communities can apply. To determine if your community is eligible [visit the MIRA MAP at this link](#) to review eligibility.

19. Awarded Applicants will be provided an Award Agreement via email. This agreement must be executed by the Applicant's Executive Authority and returned via email **no later than 15 business days from receipt.** **Failure to return a signed agreement by the due date may cause the funding award to be revoked.**
20. Applicants will be required to submit a final report with their final reimbursement request which will include a narrative and budget form.
21. The Applicant is responsible for all expenses until submitting for reimbursements. **THE AWARDED COMMUNITY IS RESPONSIBLE FOR PAYING ALL EXPENSES UPFRONT AND SUBMITTING FOR REIMBURSEMENT AT THE COMPLETION OF THE PROJECT, WHICH INCLUDES FINAL REPORTING AND INSPECTION.**
